Local Elected Officials: Please ask Congress to preserve funding for bicycling and walking

Mayors, city councils and other local elected leaders often rely on the existing federal transportation programs—Transportation Enhancements, Safe Routes to School, and Recreational Trails—for much-needed dollars to support bicycling and walking infrastructure. These improvements make it safer for children and families, increase transportation accessibility between homes, schools, jobs and store, and make towns and cities more economically competitive.

However, the U.S. Congress has been debating eliminating these programs altogether, which would leave all transportation funding entirely in the hands of state Departments of Transportation. The Senate reached a good compromise, called the Cardin-Cochran agreement, that ensures that local governments will be able to compete for these transportation dollars.

The House and Senate have now entered into a conference on the transportation bills to work out their differences and produce a final transportation law. We need local elected officials — mayors, city councilors, county officials and more—to contact Congress to urge them to retain the Cardin-Cochran compromise.

Simply use the two letter versions below to contact your two Senators and Representative. There are two versions, one for the nearly 50 Members of Congress who have been appointed to the transportation conference (conferees), and one for all other Members of Congress. Here are step-by-step resources to help you in sending the letter:
