STATE PARKS ®

Land & Water Conservation Fund (LWCF)

Project Types:

• Wide variety of outdoor recreation facilities, including trails.

Funding:

- Approximately \$4 million annually
- 60% of funds for local gov'ts, up to 40% for state agencies
- 50% match requirement

Applicants: local, state, and tribal governments

Public Use:

- Entire park boundary **must be dedicated for public outdoor** recreation use in perpetuity
- Trail projects within existing LWCF boundaries are a great fit

Grant Cycle:

- Opens September 1*
- Applications due November 1*

Local Government Grant Program (LGGP)

Project Types:

• Wide variety of outdoor recreation facilities, including trails.

Funding:

- Approximately **\$6 Million** Annually. (Oregon State Lottery)
- Match requirement varies by population (20-50%).


Funding Categories:

- Small Grants: Up to \$75,000.
- Large Grants: Up to \$750,000, \$1M for acquisitions.
- Master Planning: \$40,000 max, eligibility limited by population.

Applicants: Cities, Counties, Metro, Park and Recreation Dist., and Port Districts.

Next Grant Cycle: January 2024

• Due date differs by funding category.





Recreational Trails Program (RTP)

Purpose: To provide, expand, and improve public recreational trails for motorized and non-motorized use.


Funding: Approximately \$1.5 million annually

- 30% set aside for motorized trails
- \$10,000 minimum award
- \$150,000 recommended maximum award for non-motorized trail proposals
- No maximum for motorized proposals
- 20% match required

Applicants: local, state, federal, Tribal governments. Nonprofits registered with the Oregon Secretary of State for at least three years prior to application may also be eligible.

Grant cycle:

- Opens September 1
- Letters of intent due September 30
- Applications due November 15 *Dates may be subject to change.




